Investment Objective and Benchmark Index

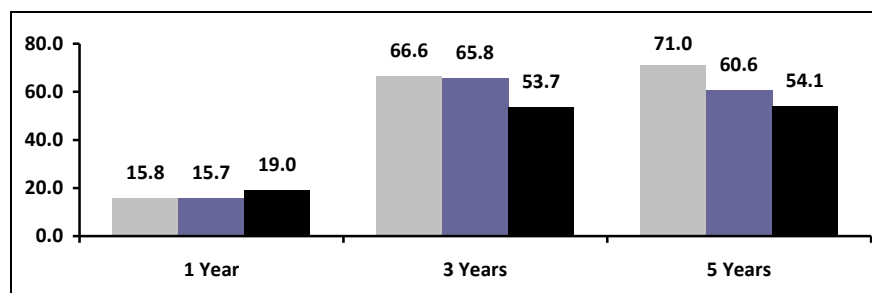

Commentary

In May the NAV (total return, sterling adjusted) was up 4.4% compared to the MSCI World Health Care Index (total return, sterling adjusted) which was up 4.2%.

Large cap pharmaceutical stocks continued their upward movement, begun in April, during the month. After a >7% move last month, pharma stocks moved >3% this month. Leading the way were key holdings Novartis and Roche, up almost 9%. Despite the group rally in pharma since mid-March, we remain selective on the large cap pharma stocks. Key contributions also came from Japan in particular, our secular investment in generic drug manufacturers was strong, including Sawai Pharmaceutical and Towa Pharmaceutical. Performance was fuelled by strong fiscal year end results and forward-looking guidance. Any lingering impact of the Great East Japan Earthquake has been negligible. Additional contributions came from a variety of sub-sectors, including medical devices (most notably Volcano as a result of a better-than-expected 1Q) and managed care and specialty pharma (such as Elan, post-transaction with Alkermes and rising expectations for their multiple sclerosis drug, Tysabri). The only significant headwind in the month came from emerging biotech, specifically Allos Therapeutics, where the disappointing launch of Fotolyn continued, as confirmed by quarterly results and a lowering of sales guidance by the company. Additionally, a partnership for Fotolyn was announced, partially defusing some of the M&A bid that was in the stock. With expectations reset, we are constructive on the stock.

Biography

Samuel D. Isaly has been active in international and healthcare investment throughout his career, beginning at Chase Manhattan Bank. He studied international economics, mathematics and econometrics at Princeton and the London School of Economics. Mr Isaly joined SG Warburg and Company Inc in 1986 where he became a Senior Vice President. In March 1989, he became the initial founding partner of Mehta and Isaly. He became the initial founding partner of OrbiMed Capital LLC, created on January 1, 1998, upon the dissolution of Mehta and Isaly.

Investment Manager Profile

Investment management services are provided by OrbiMed Capital LLC (OrbiMed). OrbiMed is owned by seven principals, including Samuel D. Isaly, who have between them many years experience of valuing companies in the pharmaceutical, biotechnology and healthcare sectors. The US-based company employs over 40 experienced investment professionals who carry out extensive research, which involves company visits and developing an understanding of commercial prospects and development programmes for individual drugs. The company database covers some 600 international pharmaceutical and biotechnology companies, two thirds of which are actively researched. OrbiMed Capital LLC is registered as an investment adviser under the U.S. Securities and Exchange Commission.

Investment Policy

The Company offers a superior UK-listed opportunity for capital appreciation through a diversified portfolio of worldwide biotechnology, pharmaceutical, healthcare equipment, healthcare technology and healthcare services companies. The Investment Manager seeks to reduce risk through extensive fundamental research, worldwide exposure, position limits, and balanced market capitalisations. The Company's investment objectives also allow gearing of up to the lower of £70m or 20% of net assets and an exposure to derivative investments of up to 5% of the investment portfolio.

Discount Control Mechanism

The Directors have adopted an active discount management policy to establish and support an improved rating in the Company's shares through the use of share buybacks, with a view to limiting the discount to NAV per share at which the shares trade to no more than 6%. Shares bought back may be held in treasury for reissue at later dates at not more than the discount at which they were purchased, and in any event at a discount no greater than 5% to the prevailing net asset value per share. Any shares left in treasury are cancelled around the time of the AGM.
